





#### **SUMMARY**

Council outperformed the 11am Official Cash Rate market benchmark for 1 month annualised return of 0.75%, with a return of 1.15% for its At Call investments for the month of February 2020. Council also outperformed the 1 month annualised Bloomberg AusBond Bank Bill Index of 0.95% for the month, with an average annualised return of 2.40% for its overall portfolio return, including an average on Term Deposits and Floating Rate Notes of 2.60%.
