From Monday 11 October 2021

- Only pre-approved DRLM Staff, DRLM agents, DSSA staff, genuine registered pre-approved buyers (and carriers who are to remain with truck and must not attend sale) are permitted on site. Pre-approval attendance to sales is centrally coordinated by DSSA Secretary.
- **Upon entry, pre-approved attendees will be required to show proof of a negative COVID test taken within 7 days of each sale.**
- COVIDSafe Plan in action including; COVID QR Check-in required, masks required indoors, physical distancing.
- Café – takeaway only, separate COVID QR Check-in required, masks required indoors, physical distancing.

From Monday 18 October 2021

- Only pre-approved DRLM Staff, DRLM agents, DSSA staff, genuine registered pre-approved buyers (and carriers who are to remain with truck and must not attend sale) are permitted on site. Pre-approval attendance to sales is centrally coordinated by DSSA Secretary.
- Surveillance testing is encouraged but not mandatory for entry.
- COVIDSafe Plan in action including; COVID QR Check-in required, masks required indoors, physical distancing.
- Café – takeaway only, separate COVID QR Check-in required, masks required indoors, physical distancing.

From Monday 1 November 2021

- Registered buyers, all vendors and genuine buyers welcomed back.
- All attendees to record attendance on site via COVID QR Check-in.
- COVIDSafe Plan in action including; COVID QR Check-in required, masks required indoors, physical distancing.
- Café – takeaway only, separate COVID QR Check-in required, masks required indoors, physical distancing.

From Wednesday 1 December 2021

- General population welcomed back.
- All attendees to record attendance on site via COVID QR Check-in.
- Café – indoor seated dining as per Public Health Order and any density limits. Separate COVID QR Check-in required, masks required for front-of-house hospitality staff only.
