That Ordinary Council meetings be held on the fourth Thursday of each month commencing at 5.30 pm, with the exception of December, where the Council meeting will occur on the second Thursday of the month to allow for the end of year holidays.
That Ordinary meetings of Council be held in the Council Chamber in Dubbo, unless otherwise resolved.
That the Code of Meeting Practice be reviewed and adopted as soon as practicable to reflect any changes to the scheduling of
