Dear Premier

I write to you for two purposes.

Firstly, to provide you with information on recent events concerning Dubbo Regional Council (DRC) that have been the subject of media coverage and to explain how DRC intends to respond to them.

Secondly, to bring to your attention serious concerns I have that conduct engaged in by your Minister for Local Government, the Hon. Shelley Hancock MP, has directly undermined the investigation of possible misconduct.

On the 16 March 2021 serious allegations of abuse of power came to my attention concerning Mayor Ben Shields.

Since then a large number of further complaints have come to the attention of myself and other Councillors.

I referred a number of these complaints to the NSW Police on 6 April 2021. Others are also the subject of complaints under the local government code of conduct process.

On 31 March 2021 seven of the ten DRC Councillors requested the Mayor to stand down. The Mayor later that day was hospitalised following a reported medical episode. He has remained in hospital since and on 12 April 2021 was granted extended medical leave by council.

I note that on 31 March 2021 the same seven Councillors also issued a public statement calling upon members of the public who may have had inappropriate interactions with any Councillor to come forward and utilise council complaint processes.

On 12 April DRC met in an Extraordinary Council meeting and passed the enclosed resolution. We believe it is an appropriate response to the allegations that have been made.

I note that earlier on 12 April the Daily Telegraph reported that allegations against Ben Shields had been referred to the NSW Police.

- Suggested that Mayor Ben Shields had been the subject of "bullying and harassment" from councillors which, "had to stop".
- Suggested DRC had been a "good council" and Ben Shields, a "great mayor", who she, "has had a lot to do with".
- Threatened "further action" against the council if we proceeded with intended motions.
- Stated she had "never seen anything so appalling" and "would not sit back and let it happen".
- Stated that she was, "warning councillors" that their "bullying and harassment must not go on".

I note Minister Hancock wrote to myself and DRC interim CEO Dean Frost that day in somewhat similar terms. I enclose that letter.

I raise with you the following serious concerns:

- That Minister Hancock has thoroughly prejudged issues concerning DRC and threatened use of her statutory powers despite having so prejudged the issues;
- That Minister Hancock's media statements have a direct tendency to discourage possible complainants from complaining about Mayor Ben Shields, or indeed any other councillor; and
- That Minister Hancock's statements could be seen as a threat of reprisal against a person for making a police report.

Please be assured that DRC will not be dissuaded from responding appropriately to allegations of misconduct.

We will not tolerate, facilitate or condone abuse of power in any form.

I am writing to express my concern about the situation at Dubbo Regional Council.

I am most concerned to hear comments that have been made on the radio and in the print media in relation to the circumstances regarding Clr Shield's medical condition and Council's functioning going forward.

I was most concerned to hear that some councillors are considering not granting CIr Shields a leave of absence, particularly under the circumstances in which he finds himself. I remind all councillors of your obligations under the Model Code of Meeting Practice (Code). Clause 5.6 of that Code requires:

The council must act reasonably when considering whether to grant a councillor's request for a leave of absence.

The Government will be watching closely as the Council holds an extraordinary meeting today and I strongly urge councillors to act reasonably and get on with the job they were elected to do serving the local community. Should I view Council's actions at its meeting to be unreasonable then I will consider enacting further intervention options available to me.

I expect all councillors to be committed to the high standard of behaviour required of people in local government, and view with great concern councils that do not act in the best interests of the community. Your time and efforts as a councillor are best directed to this end, rather than to internal disputes.

I ask that this letter is provided to all councillors and tabled at Council's extraordinary meeting on Monday 12 April 2021.
