Council will balance all relevant factors including initial cost, whole of life cost, quality, reliability and timeliness to determine actual money for value. Council is committed to conducting with fairness and probity in purchasing goods and services in accordance with Section 55 of the Local Government Act 1993 (NSW), the tender provision within the Local Government (General) Regulation 2021 - Part 7- Tendering and in accordance with the Council's adopted policies and associated procedures.

GETTING REGISTERED

Use the below steps to register and create an account with the Vendorpanel Portal:

Step 1 | You will need to access our <u>Vendorpanel portal</u>.

Step 2 | If you are already registered with the portal, you would have received a confrmation (including your username and password details) via email.

Step 3 | Use these details to log in and select the industry categories

that are relevant to your business. This will improve the types of notilcations you will receive. This is important to make sure you only receive the notilcations of interest to you and are relevant to your business.

Step 4 | If you have not registered, you will need to register and create an account by accessing the <u>Vendorpanel portal</u>. The process is very simple and only takes a few minutes. Select the registration tab and enter your email address to create your unique supplier prolle. Once completed, you will receive a con!rmation email of your registration.
